Cleary Buckley addresses the committee as it pertains to the Burlington building code. Section 8-2 of the Burlington code of Ordinance, where 10% of new residents are "accessible." Cleary states that they have come to the understanding that the department of permitting and Inspections views accessible as spaces that are adaptable and visitable and is language that relates directly to the federal Fair Housing Act. Stating that "I think that's an incorrect interpretation of what the intent of this section in the code of ordinance was trying to do was require more accessible and not adaptable or visitable for residents"

Councilor Carpenter, encouraged that the committee follow up with the Department of Permitting and inspections to better understand state and federal law, and what or how Burlington is trying to go beyond on items of accessibility.
