What kind of precautions will you take to prevent underage sales?

To prevent underage sales at our cannabis retail store, Full Tank Flower we will implement the following precautions:

1. **ID Verification**:

- Require all customers to present a valid government-issued photo ID upon entry and at the point of sale.
- Utilize advanced ID scanning technology to verify the authenticity of the IDs and detect any falsifications.

2. **Staff Training**:

- Conduct regular training sessions for all employees on the importance of preventing underage sales and how to spot fake IDs.
- Update staff on the latest town and state regulations and best practices in age verification.

3. **Store Policies**:

- Implement a strict "no ID, no entry or sale" policy.
- Display clear signage before you enter and throughout the store stating that sales to individuals under 21 are prohibited.
- Restrict entry to individuals 21 and older by having a designated staff member check IDs at the entrance.

4. **Surveillance**:

- Install high-quality security cameras to monitor all transactions and ensure compliance with age verification protocols.
- Regularly review footage to ensure staff adherence to policies.

5. **Audits and Compliance Checks**:

- Conduct internal audits to ensure all employees follow the age verification procedures.
- Cooperate with state regulatory bodies for compliance checks and be prepared for unannounced inspections.

6. **Community Engagement**:

- Educate the local community about the risks and laws regarding underage cannabis use.
- Partner with local organizations to support youth prevention programs.
