Dear Kimberlee and members of the Committee,

This is Daniel Palmer. I am a resident of Shelburne, born and raised in Bristol, VT. I have extensive bar experience including building and operating many restaurants; Sweetwaters, Ice House, Sirloin Saloon and 12 years of building restaurants nationally for TGIFridays. After many years I finally fulfilled my dream of opening my own place in Bristol called Dan's Place from 2008 through 2012. I have had extensive experience with late night clients and made my own decision to close at 11:00pm with last call, and everyone out by midnight. Nothing good ever happens after midnight. We eliminated that late night atmosphere...

I have a love for our city of Burlington. This is where I have played and worked most of my adult life. In having this experience with the late night scenes in restaurants and bars, I feel a great concern for the city's safety and the people in it. My proposal for the city of Burlington is to do the same; last call at 11:00pm and everyone out by midnight with live music ending at 10pm. We could take it one step further with a curfew in downtown Burlington by 1:00 am.

On the economic side of things, it will be a win-win for all of the businesses. The bulk of all the money made downtown by food and bar wages and tips is between 4pm and 11pm. After 11pm the business starts dropping off. If business owners run their late night numbers they will see that they are losing money by staying open beyond then.

My feeling about what we did in Bristol by closing establishments early, including the American Legion, was that we eliminated the atmosphere of danger and everyone went home to their families. We need to put a cap on these late night hours in an effort to protect our people and create a safer downtown area. Staying open until 2am is creating a late night atmosphere of trouble. Parents of the college students and bar employees will be so happy to know their children are safely home earlier.

I believe that if we can accomplish this, other Police Officers around our New England area will see that we are trying to get control of our city. I feel we will receive more applicants that will want to come and work for the city of Burlington once they see that we are trying to curtail the bad behavior.

Please consider this on a trial basis for one year. Maybe we can extend this to a statewide policy once we have tried this and proven its success. Please hear me.
