Barry Bryant stated he has sent the information to Mellon regarding the allocations and suggested a phone meeting with Mellon, Bob Rusten, Kim Sturtevant and himself to review the contract and ask any questions that the City may have before signing the contract. Bob Rusten suggested sending the contract out by email and if anyone has any objections to the contract they could contact Stephanie Hanker and a special meeting can be convened.

8. Discussion of Administration Recommendation on Non-Union Employee Contributions

Bob Rusten stated that typically non-union employees follow AFSCME employees when it comes to contributions for benefits. Bob Rusten stated that AFSCME has settled their contract and is briefing the Board the Administration was going to send a resolution to the City Council to increase the non-union employee contribution to match that of the AFSCME contract, effective January 2016 the contribution will increase to 3.4%, July 2016 the contribution will increase to 3.8% and July 2017 the contribution will increase to 4.2%.
