New Business

a. Update on Voter Challenge and Purge Lists

Amy Bovee informed the Board that voter challenge letters were sent out in mid-August. All voters who were on the purge list have been removed from the checklist. In response to a request from Board members, she reported that of the voters who were challenged lived in the following wards:

Ward 1 – 13%

Ward 2 – 16%

Ward 3 – 15%

Ward 4 – 8%

Ward 5 – 10%

Ward 6 – 13%

Ward 7 – 7%

Ward 8 – 17%

She said she would provide the Board with an update on the response when more responses had come in.

b. Update on New Member Recruitment

Amy Bovee reported that the two newly created positions have been posted. The Board reviewed a letter to City Councilors. Amy Bovee agreed to send the letter to the City Council and ask that it be posted on Front Porch Forum citywide. Board members discussed recruiting friends, neighbors and speaking at their NPAs. The Board agreed that they would like to recruit people from different background and from Wards that are not currently represented on the Board.

c. SSN Issue
