Gordon Gokey: Issues are noise level ordinance on Church Street. Tried to get a long with Red Square when they turn up the bass it shakes the apartments and things have fallen off table. Stage on side is in fire lane and when the fire on the building couple weeks ago the fire truck had hard time getting into the lane. Suggested to move speaker as it vibrates wall and windows, requested to move speaker near the other side next to the tattoo parlor.

Neighbor 1: Bass gets very loud by indoor DJ and it shakes the building.

Neighbor 2: If you were to view this by living above a night club, lived there 10 years has improved but still unreasonable. 3 venues in Red Square that are competing with each other. Noise ordinance is ambiguous, Red Square is exempt because they have entertainment license. Quiet all day then 10 pm at night it gets loud and even louder between 12 and 2.

Councilor Roof lived above Red Square and will call Cormac the owner of building as a result to this discussion as there is no action to be taken. Also possibility to bring someone in to do decimal level readings.

Councilor Ayers volunteered to meet with Cormac as well with Councilor Roof to go over what has been said.
