7:50 – South End Innovation District (Meagan Tuttle, Charles Dillard, Planning Dept)

Presentation

Charles Dillard speaks to the planned zoning changes to the innovation district, west of Pine st in the South End

Will allow housing, as opposed to the original plan for the district

Hundreds of new homes and neighbors

Land use - buildings will be attached, generally apartments, town homes etc

- Not planning on allowing single family detached homes, hotels, heavy manufacturing

Planning to return to Ward 5 NPA in June for a more detailed presentation

Jane Headley - asks if banks or grocery stores will be allowed, what the options will be for people who aren't as mobile?

Charles - small grocery will be allowed, as well as banks under the umbrella of small retail. The proposed transit center could increase transportation options.

Andy Simon - Requests that Planning do more outreach with the public, is concerned about a hotel being allowed in the innovation district.

Charles - City Planning is planning to come back to the June NPA

Terry Rivers - asked whether the nordic spa was permitted yet, whether it would be allowed to have a large parking lot.

Samantha Dunn - the project has not applied for permits yet.

8:10 – Transit Depot at Lakeside Ave? (David Saladino, Jeff Dube, VHB Consultants)

The City is partnering with the CCRPC to study the feasibility of a multimodal transit center to house around 550 cars in a parking facility, replacing and condensing the parking in the South End.

Terry Rivers - is it because we don't have enough parking in the downtown?

David - No, it's for consolidating the parking for the south end, Hula, etc
