2. Public Forum	We had one member of the public joining us to observe the Board of Health. He is interested in becoming a BOH board member.	
3. Pesticide Applications and Products a. BPRW – Bike Path at Harrison Avenue b. Global Companies	a. Burlington Parks & Rec Dan Cahill and Bob Hayms joined the meeting to continue the discussion of how to eradicate the knotweed on the bike path at Harrison Avenue. As mentioned in last month's meeting the rehab of that section of the bike path caused the knotweed to spread into the new infrastructure, compromising the integrity of the work done. The BPRW Department is currently using mechanical means of keeping the knotweed	

	from spreading even further into the infrastructure of the bike path. It has slowed the spreading for now but is not an effective long term solution. Chemical eradication will be the best way to save the Burlington residents from having to pay for another rehab of this section. All parties involved take the lake health very seriously and will use the least amount of herbicide as possible to eradicate the knotweed. Through the discussion it was realized that the railroad company has been maintaining the knotweed on their right of way. However, the herbicide company has found that their method is not being done properly and therefore is not as effective as it could or should be. With the railroad right of way and their methodology for keeping the knotweed in control, the Board of Health would like to see a discussion and hopes for collaboration with the Railroad. This would allow the City of Burlington to treat this invasive knotweed with the least amount of herbicide but giving the best results. Therefore, the BOH has motioned for BPRW continue with the mechanical method at Harrison, denying the application. There was a second motion; for the Director of Permitting & Inspections and Town Health Officer to reach out to the Railroad company to obtain information of their herbicide methods and possible collaboration on eradicating the knotweed on the bike path at Harrison Ave. b. Global Companies; 2 Flynn Avenue They are applying for pesticide use to maintain the integrity of emergency berms in place to catch and hold liquid in case of leaking. Any liquid that leaks out of the berm is a high risk to the lake.	Julie motioned; Mary 2nd, All in Favor. Application denied. Celia motioned; Mary 2nd, All in Favor. Motion passed.

7. Emerging Issues	Julie was approached by a resident regarding a neighbor's house painting project. The resident wasn't seeing best practices being used when scraping/sanding the home in preparation for new paint. This brought up a few questions; how do we know if a company is following the best practices guidelines, what are those requirements. It lead to a general discussion of the board members needing information and/or training on what to look for when a painting complaint is presented to them. What the ordinance is and what information does the Lead Program provide to those needing lead paint assistance.
