Recommend to abate penalties and interest (and other) of \$2,590.88 due to manifestly unjust as the organization was attempting to open religious exemption but took long time to organize their paperwork for the request to be appropriately documented for their PVR-137 exemption request. Exemption request was not valid until late November 2019 – mid tax year. Committee does not recommend abating any taxes due prior to the FY21 tax year – the Vermont Organization for Jewish Education choose not to pay the taxes that were owed and the committee believes they owe that money to the municipality. Tax was manifestly just and neither illegal nor uncollectible from the owner. No evidence to contrary provided by petitioner.
