Motion passes unanimously.

Action, Discussion: 3.02 Indoor Entertainment Permit Renewal: Swan Dojo

Motion to approve made by Councilor Tracy, second by Councilor Roof. The renewal is for everyday, 9 pm - 2 am, types: live instrumental music, live vocal music, disc jockey, fashion show/trade show/exhibition, stage play/pantomime, comedian, dance performance, contests/games/amusements and movies. Dancing by patrons: YES; amplified music: YES.

Action, Discussion: 3.03 Outdoor Entertainment Permit Renewal: The Skinny Pancake

Motion to approve made by Councilor Tracy, second by Councilor Roof. Benjy Adler, co-owner requested for this permit to be until 2 am every night of the week. The Committee agreed to allow for Friday and Saturday nights to be extended until 2 am, all other nights only 12 am. Benjy stated that after midnight, mellow music would be playing. No dancing as of yet, amplified music YES.
