Commissioner Blais shared with everybody his conversation that he had with DLC Investigator Prevost about this possible venture. Sink requirements would need to happen and a valid health license would need to be issued.

Shawn Burke, BPD voiced his concern and DLC's that there would be a shared terrace between the two establishments and how that would work regarding outside consumption.
