I. Approval of Agenda

III. Old Business

A. Update on position

C. Update on Section 6/Design Study

- C. Rita had three requests from the Friends of Lakeview that were asked to be addressed at the Commission meeting.
 - a. ADA access requested for the Chapel by the time of the memorial for World War 1. This can be a temporary access.
 - b. The Friends have helped to clean the chapel at higher level of care and are looking for assistance. The commission will look at the fees for the Chapel to include a more thorough cleaning of the building prior to a rental. Cindi will provide the additional staff expense figure.
 - c. The Friends requested that Jeff or Steve be on-site for the World War 1 Memorial event that is tentatively set for October.
