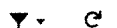

No. I did run the bar Algonquin here
for over 2 years before we changed the
LLC prompting me to apply for a liquor
license.

I have worked in the industry for over 20 years,
doing everything from prep work to GM to Beverage
Director. I ran several bar cocktail programs in NYC
before moving to Vermont in 2021 and starting here.

Yes, I have managed the bar at 111 St. Paul

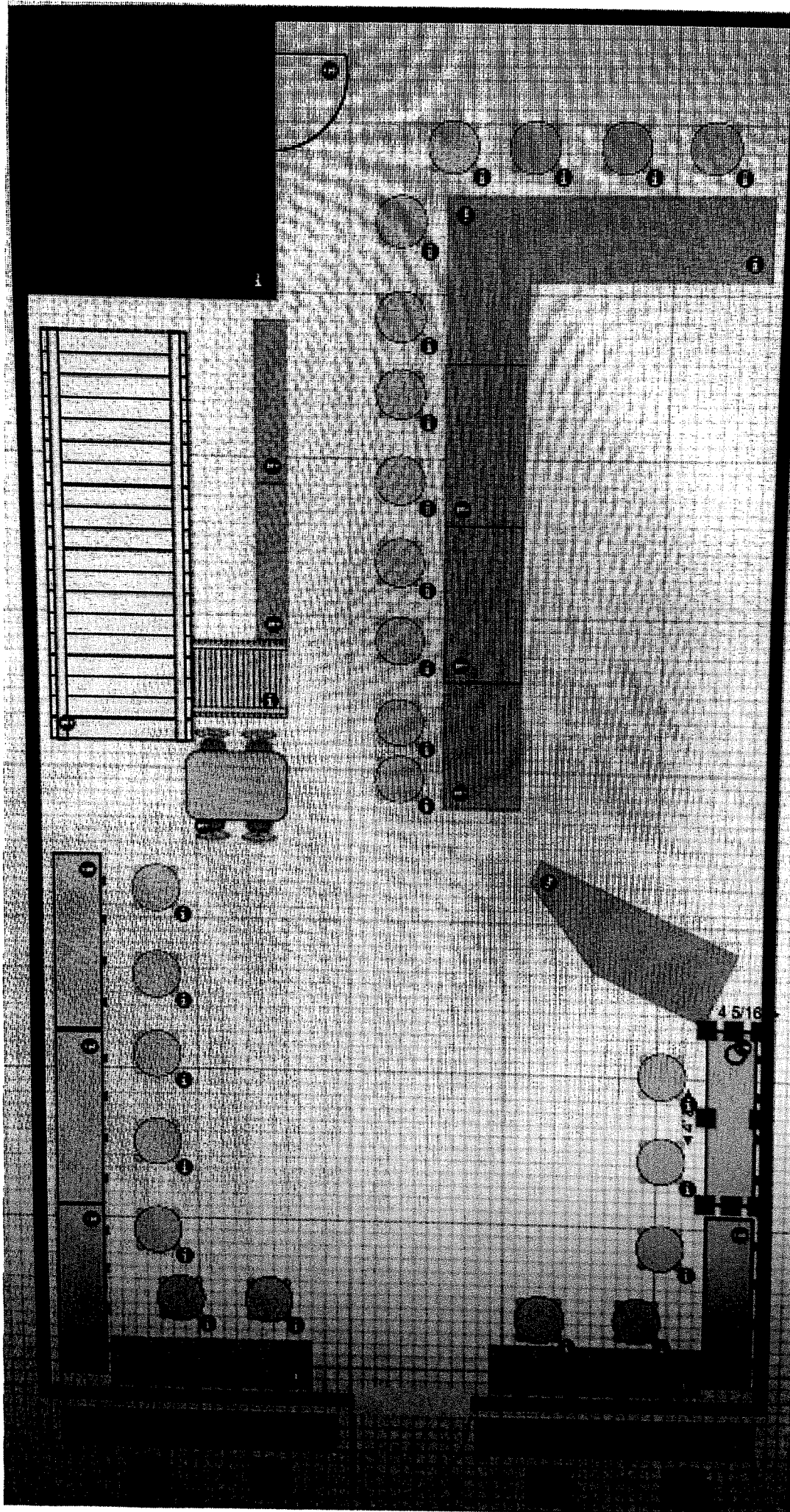

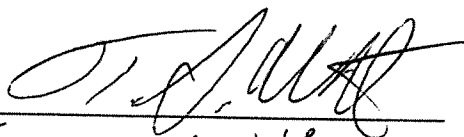
